



## CertiPUR-US® Program Supplier Verification Form A

Bedding and Upholstered Furniture Manufacturers and Retailers: In order to use the CertiPUR-US® mark you must first receive permission from AFPF/CertiPUR-US® program administrators. Here's how:

**Step 1:** Ask your foam supplier\* to fill out and submit this **Verification Form A** on your behalf by providing supplier with link to the form: [www.certipur.us/FormA](http://www.certipur.us/FormA), along with correct information about your company for Section 1. Information on the form is held in strict confidence and is only accessible to AFPF/CertiPUR-US® administrators.

- \*Note:**
- If you are using multiple suppliers, a verification form from each supplier will need to be on file. Just send each supplier the link.
  - If you are buying through a distributor, you will need a verification form on file from that distributor, who will in turn need to send the link to the company from which they buy certified foam.

**Step 2:** Submit Form B on page 4 of the *CertiPUR-US® Terms of Use Manual* to [forms@certipur.us](mailto:forms@certipur.us).

**Step 3:** Before using the CertiPUR-US® mark, wait to receive permission from AFPF/CertiPUR-US® administrators, usually within 7-10 days of submitting all required forms.
